On September 9, 2016, Front Street Capital 2004 (the "Manager") announced that it had entered into an agreement with Aston Hill Financial Inc. ("Aston Hill") pursuant to which the Manager and Aston Hill have agreed to combine their companies to create a new asset management firm which would then become the manager of the Funds. What does the fund invest in?

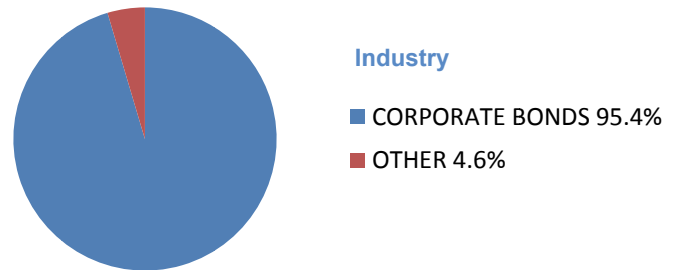
The fund invests primarily in corporate, government and other bonds, and debt instruments or debt-like securities, of investment grade and non-investment grade North American and/or international issuers.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

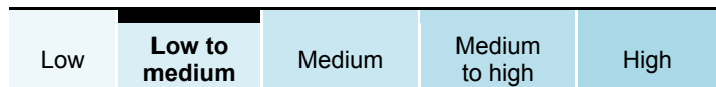
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Front Street Capital 2004 has rated the volatility of this fund as **low to medium**.

Because this is a new fund, the risk rating is only an estimate by Front Street Capital 2004. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.



How has the fund performed?

This section tells you how Series C units of the fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

Not available because the Fund has not been distributing under a simplified prospectus for a full calendar year.

Best and worst 3-month returns

Average Return

Not available because the Fund has been distributing under a simplified prospectus for less than 12 consecutive months.

Who is the fund for?

This fund is only offered for investment by Front Street Mutual Funds Limited.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following table shows the fees and expenses you could pay to buy, own and sell Series C units of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

Series C units of the fund do not have an initial or deferred sales charge.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of April 30, 2016, the fund's expenses were 0.28% of its value. This equals \$2.80 for every \$1,000 invested.

Annual rate (as a % of the fund's value)

Management expense ratio (MER)

This is the total of the fund's management fee (including the trailing commission) and operating expenses. 0.28%

Trading expense ratio (TER)

These are the fund's trading costs. 0.00%

Fund expenses 0.28%

More about the trailing commission

There is no trailing commission on the Series C units of the fund.

3. Other fees

The Series C units of the fund cannot be switched or converted, accordingly, there are no other fees payable.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund shares within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.

On September 9, 2016, the Manager and Aston Hill announced that they have entered into an agreement to combine their respective companies, creating a new, leading independent asset management firm (the "Transaction") which would then become the manager of the Funds. The closing of the Transaction, which is expected to occur by the end of 2016, is subject to a number of conditions precedent including the approval of Aston Hill shareholders and debentureholders, approval of shareholders of the Funds, securities regulatory approval and satisfaction of other customary closing conditions. Special meetings of the shareholders of the Funds are expected to be held in November, 2016 to consider the change of manager. Further details of the Transaction will also be set out in the management information circular to be prepared in connection with the meetings, which will be available under the Funds' profiles at www.sedar.com. If the necessary approvals are obtained, the change of manager will be implemented (all as described in the information circular).
