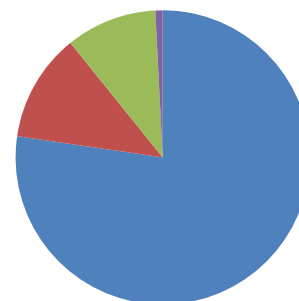
What does the fund invest in?

The fund invests primarily in corporate, government and other bonds, and debt instruments or debt-like securities, of investment grade and non-investment grade North American and/or international issuers. The fund will reduce the interest rate exposure of the portions of fund's assets that are attributable to Series H shares so that the duration exposure attributable to the Series H shares is less than two years. The charts below give you a snapshot of the fund's investments on October 17, 2014. The fund's investments will change.

As at October 17, 2014, all Top 10 investments in the fund were long positions except the Forward Contracts which is a short position.



How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Front Street Capital 2004 has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund’s returns have changed from year to year. It doesn’t tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this fund doesn’t have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series H shares of the fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce the fund’s returns.

Year-by-year returns

Not available because the Fund has not been distributing under a simplified prospectus for a full calendar year.

Best and worst 3-month returns

Not available because the Fund has not been distributing under a simplified prospectus for a full calendar year.


Average Return

Not available because the Fund has been distributing under a simplified prospectus for less than 12 consecutive months.

Who is the fund for?

Investors who:

- have a low to medium tolerance for risk and volatility
- have a medium to long-term investment horizon
- income (that does not come from Canadian sources) and security capital are important objectives

 Don’t buy this fund if you need a steady source of income from your investment.

A word about tax

In general, you’ll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series H shares of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option. Series H shares of the fund do not have an initial or deferred sales charge.

2. Fund expenses

You don’t pay these expenses directly. They affect you because they reduce the fund’s returns. The fund’s expenses are made up of the management fee, operating expenses and trading costs. The fund’s annual management fee is 1.00% of the fund’s value. Because this fund is new, its operating expenses and trading costs are not yet available.

More about the trailing commission

There is no trailing commission on the Series H shares of the fund.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Fee	What you pay
Short-Term trading fee	You may be charged up to 2% of the value of shares you sell or switch within 90 days of buying them. This fee goes to the fund.
Switch fee	Your representative's firm may charge you a fee to switch to another Front Street Capital 2004 fund.
Series H fees	You may pay fees to your representative to manage the account where the Series H shares are held. The amount of the fee is determined between you and your representative, and may be based on the amount of assets in your account.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund shares within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
